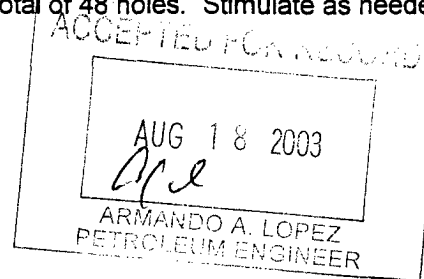

If the proposal is to deepen directionally or recompleate horizontally, give subsurface locations and measured and true vertical depths of all pertinent markers and zones. If the operation results in a multiple completion or recompleation in a new interval, a Form 3160-4 shall be filed once testing has been completed. Yates Petroleum Corporation plans to recompleate this well as follows: Set a 4-1/2" CIBP at 5350' and cap with 35' cement. Perforate Cisco 5070'-5076' (36) and 5108'-5116' (48) for a total of 84 holes. Stimulate as needed. If the Cisco is not productive, set a 4-1/2" CIBP at 5050' and cap with 35' cement. Perforate Wolfcamp 4832'-4842' for 60 holes. Stimulate as needed. If this Wolfcamp zone is not productive, set a 4-1/2" CIBP at 4800' and cap with 35' cement. Perforate Wolfcamp 4380'-4386' (24) and 4418'-4424' (24) for a total of 48 holes. Stimulate as needed.
