1. MIRU WSU & all safety equipment. No casing recovery will be attempted. TOH w/ tubing, if any.

2. TIH w/ tubing. Spot 25 sk Class C cement plug from 2662'-2852'. Pull tubing up hole & reverse circ clean.

WOC & tag plug; reset if necessary. Load hole w/ plugging mud.

3. Pull up to 1310' & spot 25 sk Class C cement plug from 1120' - 1310'. Pull tubing up hole & reverse circ clean & WOC. Tag plug, reset if necessary. Load hole with plugging mud.

4. Pull up to 525' & spot 25 sk Class C plug from 285'-475'. Pull up hole & reverse circ clean & WOC. Tag plug, reset if needed. Load hole W/ mud.

5. TIH w/ tubing to 150' to spot 15 sk Class C cement plug @ surface. Fill any voids in the annulus & WOC 24 hrs to tag plug; reset if necessary.

6. Remove all surface equipment & weld dry hole marker per regulations.
