Ran 59 joints of 8-5/8" 24# & 32# casing as follows: 16 joints of 8-5/8" 32# J-55 (645.03) and 40 joints of 8-5/8" 24# J-55 (1783') and 4 joints of 8-5/8" 32# J-55 (170.86') (Total 2598.89') of casing set at 2500'. Float shoe set at 2500'. Float collar set at 2458'. Cemented with 500 sacks Howco Lite (65-35-6), 1/4#/sack flocele and 5#/sack gilsonite (yield 1.98, weight 12.5) and 150 sacks Class C with 2% CaCl2 (yield 1.34, weight 14.8). PD 10:15 PM 8-12-2003. Bumped plug to 1100 psi for 5 minutes, OK. Circulated 200 sacks. WOC. Nipped up and tested to 2000 psi for 5 minutes, OK. Drilled out at 1:30 AM 8-14-2003. WOC 27 hours and 15 minutes. Reduced hole to 7-7/8". Resumed drilling.
