

During construction work the surface location of this well was inadvertently moved 50' north. Two wells are to be drilled from this pad and the construction crew thought this location was for the second well which was suppose to be 50' south. The other well was the US 13 Federal #4 located at a surface location @ 140 FSL 1840 FEL. The mistake was noticed after the drilling of the Shelby 12 Federal #7 and the rig was skidding to the US 13 Federal #4, which is now 100' south instead of 50'. All work was done on the existing pad that was approved by the APD, so no additional surface disturbance was done. Please see attached for an amended C-102 plat and Exhibit's B.


