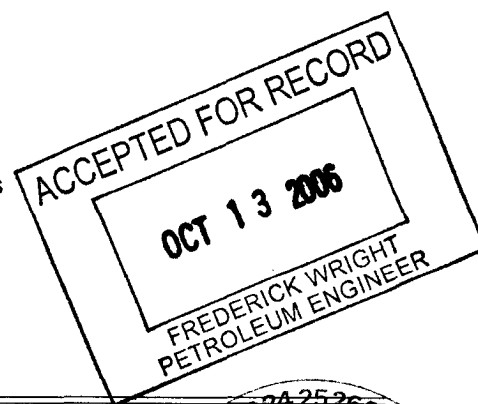

Cemented with 265 sx Poz C + 6% D20 + 3% S1 + 0.125 pps D130 + 5 ppg D24 (wt 12.6, yld 2.00) lead and 250 sx Class C + 2% CaCl2 (wt 14.8, yld 1.35) tail. Circulated 189 sx to surface. WOC 28.5 hrs. Test casing to 1000 psi for 30 mins. Drilled 7-7/8" hole to 7463'. Ran 154 jts 5-1/2", 15.5# and 33 jts 17#, J55 LTC casing set at 7462'. Cemented with 815 sx Litecrete + 2% D153 + 0.05% D604M + 0.03% M45 + 2 pps D24 + 0.04 D801 (wt 10.2, yld 2.37) lead and 190 sx Litecrete + 2% D153 + 0.05% D604M + 0.03% M45 + 2 pps D24 + 0.04% D801 (wt 10.5, yld 2.04) tail. TOC by temperature survey 2940'. Released rig on 9/24/06. Prep for completion operations.
