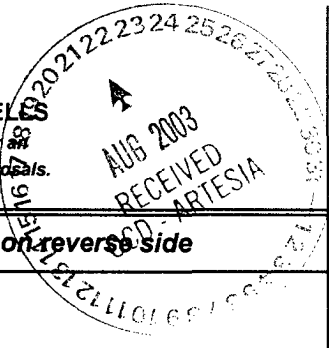

Yates Petroleum Corporation plans to recomplete this well as follows: Set a 5-1/2" composite plug at 5800' to isolate the Strawn perms. Perforate Wolfcamp 5456'-5468' with 48 holes. Stimulate as needed. If the Wolfcamp zone is not productive, squeeze these perms with 100+/- sx Class "H" cement with additives. Perforate Abo 4428'-4442' (15), 4462'-4467' (6), 4507'-4511' (5), 4584'-4588' (5), 4596'-4604' (9), 4698'-4704' (7), 4766'-4780' (15) and 4844'-4847' (4) for a total of 66 holes. Stimulate as needed.
