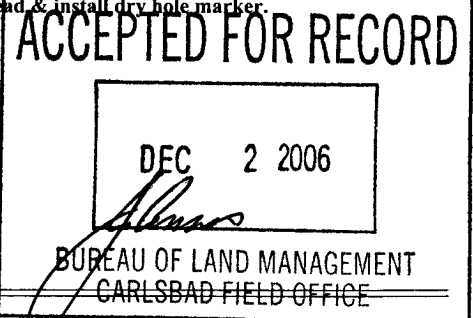

10/31/06 - Tag cmt @ 714'. Shoot 4 sqz holes @ 542'. Pump 175 sx cmt. WOC. Tag @ 244'. Shoot 4 sqz holes @ 244'. Pump 60 sx cmt. WOC.
11/1/06 - Tag @ 67'. Shoot 4 sqz holes @ 67'. Pump 20 sx cmt. Circ to surface. Cut off wellhead & install dry hole marker.
