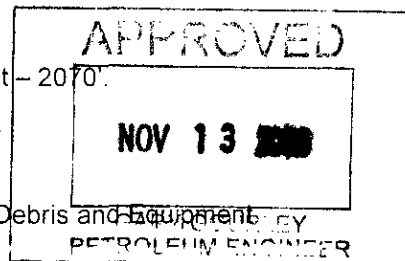

5. Level Pits, Rat Hole and Cellar. Set 4" Steel Marker, Clear Location cleared of all Debris and Equipment.
6. Notify BLM and NMOCD of Plugging Operations.
