

13. Describe Proposed or Completed Operation (clearly state all pertinent details, including estimated starting date of any proposed work and approximate duration thereof. - Yates Petroleum Corporation plans to plug and abandon this well as follows:
1. Rig up all safety equipment as needed. No casing recovery will be attempted. Tag CIBP at 3500' and load hole with plugging mud.
  2. Spot a 25 sx cement plug from 2765' to 3144' across the 8-5/8" intermediate casing shoe. WOC and tag plug, reset the plug if necessary.
  3. Perforate 4 squeeze holes at 1550'. Pump 85 sx Class "C" cement with additives. Displace the cement to 1450'. This will leave a 100' plug across the surface casing shoe. WOC and tag plug, reset if necessary.
  4. Perforate 4 squeeze holes at 150'. Tie onto 4-1/2" casing and establish circulation. Pump 100 sx Class "C" with additives. Do not displace the cement. This will leave a solid plug from the surface down to 150' for a surface plug. WOC and tag plug, reset if necessary.
  5. Remove all surface equipment and weld dry hole marker per regulations.

**NOTE: Yates Petroleum Corporation will use steel pits and no earth pits**




