11/9/06 - Top tubing joint has hole in it. 4-1/2" casing has hole just below bell nipple. Well started flowing through hole. Ran RBP down 30' and set.
11/10/06 - Pushed packer to bottom at 1594'. Set RBP at 915'. Started testing casing. No leaks other than right below bell nipple and top joint of tubing head with hole in it.
11/13/06 - Dig out cellar down to 7" casing. Cut off 4-1/2" casing. Build up new casing and bell nipple. Tested casing to 500 psi, held OK. Fill in cellar.
11/14/06 - Released RBP. TIH with 4-1/2" NP tension packer and 2-3/8" IPC J-55 tubing. Circulated packer fluid. Set packer at 930'. Tested to 500 psi for 30 min, held OK. NOTE: OCD did not witness, received verbal from Gerry Guye. MIT attached.
