

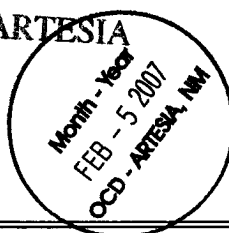

Yates Petroleum Corporation respectfully requests permission to extend the Temporary Abandon status of this well. This well is a candidate for the horizontal wolfcamp shale that we are currently in the process of gathering information on to evaluate which has been discussed with Fred Wright (BLM). There is also some upper yeso that has potential pending the horizontal evaluation. We hope to have the wolfcamp shale fully evaluated in a year + depending on the results of other wells testing.
