- Inform "OCD" 505-748-1283 EXT ~~102~~ 105
- MIRU service rig, kill well, N/D tree, N/U bop's.
- Release packer, and pooh with 2-3/8" tubing. Lay down packer.
- Gih with bit & scraper, clear 7" casing to 2570'. Circulate well if necessary.
- Pooh with tubing string, lay down bit & scraper assy.
- RU wire line unit. GIH with 7", 20# CIBP. Set CIBP at 2550' above squeezed perforation of 2608'-2726'
- Dump bail 10' of cement on top of CIBP. Test 7" casing & CIBP 500 # for 30 minutes. Using pressure recorder.
- If testing 7" casing is successful. GIH with 2-3/8" tubing open ended
- Install well head equipment and T/A well. Provide form C-103 for Subsequent work. Notify 24 hrs PRIOR
