02/26/07 MIRU, set 20" conductor; 36" hole drill @ 40'.

**Note:** Devon respectfully requests a 60 day extension to hold the lease from expiring. Have set conductor until a bigger rig (Patterson #74) is scheduled to be on location mid March. Due to our previous location problems with the Coyote 14 Federal 2, rig was approved by the BLM to be skidded to new Coyote 14 Federal 2Y location; and caused a scheduling delay for the Acme 10 Federal 1.
