Due to recent Geological determination of Salt depth in the area, BEPCO, L. P. respectfully request to alter the original surface casing setting depth from 13-3/8", 54.5#, J-55 casing at 932' to 415'. *Set above salt which will probably appear at approximately 500'.*

Due to the potential of encountering overpressured gas bearing zones below 10,400', BEPCO, L.P. respectfully requests to alter the original intermediate casing plan for the above captioned well. The proposed 9-5/8", 40# ppf, N-80 intermediate casing string setting depth of 5850' be extended to 5980'.
