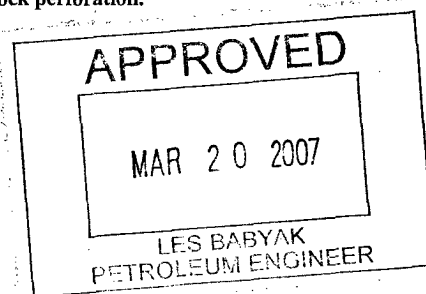
Will convert oil well to water injector as part of 8 well waterflood (described in 3 ring binder application received by BLM 2-20-07).

Stimulate with approximately 5,000 gallons 15% NEFE HCl to clean out scale or fill.
