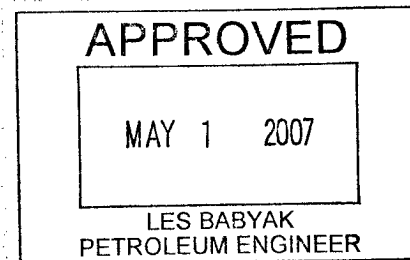

Yates Petroleum Corporation respectfully requests an extension on the following well TA status in order to evaluate and possible recompleat to the Cisco Canyon along with other area wells. This zone had not been tested in the area prior to the intent to P&A being sent.

We have several procedures written to test this interval in surrounding wells which are currently being processed. Plans are to test this interval in area wells within the next 12 months if all the land issues can be resolved. We would like to test all options in this area before giving up any of our well bores.
