3/31/04 - POOH w/ 60 joints kill string. RU WL. RIH w/ 5-1/2" CIBP. Set at 8,555'. POOH w/ WL. Made 2 dump bailer runs on top of CIBP. TOC at 8,520'. POOH w/ bailer. Re-dress setting tool. RIH w/ 5-1/2" CIBP, set at 7,986'. POOH w/ WL. RD WL. RIH w/ 60 joints 2-7/8" tubing. SI. SD.

4/1/04 - Opened well. RIH w/ tubing. Tagged CIBP at 7,986'. Circulated hole w/ mud laden fluid. Spotted 25 sx Class C Neat cement at 7,986' to 7,733'. PUH to 5,433'. Loaded hole w/ mud. Spotted 25 sx Class C Neat cement at 5,433'-5,180'. PUH to 2,651'. SI. SD.
