3/9/07 RU. Acidize with 3000 gallons 15% HCl acid. Release packer. TOOH with tubing and packer. ND BOP. NU Frac valve.  
3/12/07 RU. Frac San Andres with 22,000 gallons Aqua Frac 1000 + 135,500 # 100% 20/40 sand + 24,500 # 100% 16/30 Siberprop and flush with 1,785 gallons slick fresh water. RD  
3/13/07 Flow well back.  
3/14/07 TIH with bailer - bail sand. TOOH with bailer. TIH with pump, rods, and tubing. Hung well on production.
