Work began 8/11/03. MIRU PU, kill well, ND wellhead & NU BOP and Torus annular. Function test BOP and RU cable spoolers. POOH w/sub pump & auger system and LD. RIH w/retrieving tool, latch on to RBP, release and POOH. RIH w/bit & casing scraper to 8648' tag. POOH and found no fill. POOH, PU and assemble scab liner (4 joints 5-1/2" Rite-wrapped casing) and hydraulic packer assembly to 7962'. Set both upper and lower packers, loaded and tested. Dropped ball & chased w/58 bbls of water to shear. After several attempts, the annulus unloader did not activate. Swabbed well, 70 runs removing 228 bbls of load to equalize. Unjayed from casing patch packer & POOH. PU & assemble sub pump & RIH to top of scab liner. Landed hanger in wellhead and made final splice. ND BOPs & NU wellhead. Hung well off and turned well over to production 8/16/03.
