7/10/07 No tag. Re-spotted 35 sx cement with 3% CaCl₂ and WOC. Tagged at 3420'. Circulated plugging mud. Tested casing to 500 psi.

7/11/07 Perforated at 2520'. Spotted 30 sx cement at 2570' and WOC. Tagged at 2170'. Perforated at 297'. Pumped 35 sx cement and WOC. Tagged at 180'.

7/12/07 Spotted 15 sx cement and circulated to surface. Cut off wellhead. Installed dry hole marker. **WELL IS PLUGGED AND ABANDONED. FINAL REPORT.**
