6/10/07 - WOC. TIH - did not tag cmt. 2nd attempt - set 125 sx Class "C" Neat cmt plug @ 700' - 500'. WOC. TIH & tag cmt @ 254'. Set 25 sx Class "C" Neat cmt plug @ 75' to surface. Cut off well head. Install dry hole marker.

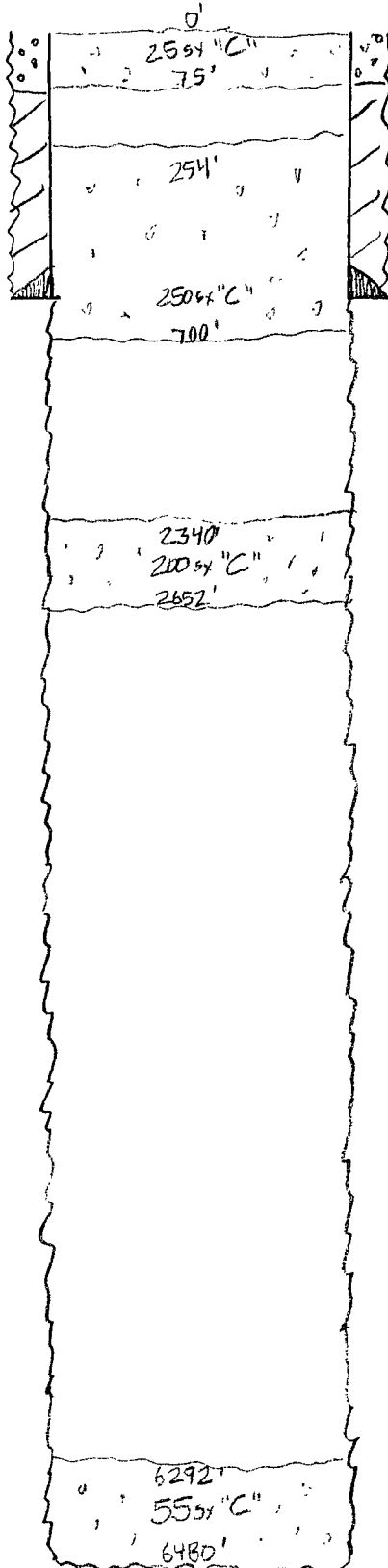
