This well is currently producing from the Grayburg formation at a depth of 4158'-4168', at a rate of 1 BOPD, 10 BWPD, 1 MCFD. Plans are to squeeze the Grayburg, drill out 2 plugs and recompleate the Bone Springs 1st Sand as follows:

1. Squeeze Grayburg 4158'-4168' w/100 sx cmt.
2. Drillout cmt & CIBP's @ 4500' & 5850' to new PBTD - 7865'.
3. Perforate Bone Springs 1st Sand 7616'-34', 7650'-60' w/lspf, 30 holes
4. Acidize w/1000 gal 7 1/2% NEFE HCL.
5. Frac w/39,000 gal + 67,000# 20/40.
