Additional Comments: Work Plan for the closure of drilling pit. The drilling pit contents will be mixed to stiffen the pit contents. An encapsulation trench will be excavatedand lined with a 12 mil synthetic liner on former drilling pit site. Drilling pit contents will then be emplaced into the encapsulation trench. A 20 mil synthetic liner willthen be placed over the pit contents with a min of a 3" over lap of the underlying trench area. Then encapsulation trench will then be backfilled back to grade using a min of 3'of clean soil and hike material. A one call and 48 hr notice will be provided to the Oil Conservation Division before pit closure actions begin. Pit closure actions will begin

1 week after permit approval.

If burial trench is to be constructed

and analyses submitted to OCD  
PRIOR to lining trench.

NOTIFY OCD 24 HOURS PRIOR to
