13-3/8" 54.5 ppf J-55 STC Casing (17-1/2" hole), 1,350 - 1,900' RKB (est.) Cement to surface.

9-5/8" 40 ppf K-55 LTC Casing (12-1/4" hole), 0 - 3,100' RKB (est.) Cement to surface.

The permitted casing weights were 48 ppf and 36 ppf respectively.

Operator will use 10.1 ppf mud for surface casing
Note: 5 1/2" production casing cement to extend a
minimum of 200' inside 9 5/8" casing.
