We must request a time extension to complete this work.

The present condition of the well is waiting to be put on production.

Our 9/12/2007 work report shows I&W tested casing to 500 PSI for thirty (30) minutes- with no leak off. This testing was discussed with BLM's Terry Cartwright on 9/11/2007. He advised they would not witness. We have a pumping unit change in the process (larger unit) for the well. This may also require some electric service update. We have ordered new rods and tubing for this well and are securing a rig for as soon as the pumping unit move has been completed.
