The Ozley 25 Federal No. 1 is currently producing from Cisco-Canyon perfs @ 10130'-10150' and 10160'-10170' (Morrow zone is perforated @ 11350'-11354' w/ CIBP @ 11010' & 11572'-11582' w/ CIBP @ 11550' & 11650'-11686' w/ CIBP @ 11625').

Cimarex proposes to re-enter, set a CIBP @ 10125' w/ 35' cmt, and perform the following operations:

Perforate Cisco-Canyon @ 9990'-10109' w/ 6 spf, 60 degree phasing, 347 holes total. Fracture stimulate as necessary.

TIH w/ 2-3/8" tubing and flow well as Chosa Draw; Upper Penn gas well.
