10/20/07 - Resumed drilling at 12:30 AM.

10/21/07 - Set 8-5/8" 24# J-55 casing at 1105'. Cemented with 400 sx 35:65:6 Poz "C" + 0.125#/sx D130 + 5#/sx D24 + 3% S1 (yld 1.99, wt 12.6). Tailed in with 200 sx Class "C" + 0.125#/sx D130 + 2% S1 (yld 1.34, wt 14.8). Cement circulated to surface. Tested casing to 1000 psi for 30 min. WOC 19 hrs 30 min. Reduced hole to 7-7/8" and resumed drilling.
