We received authorization to plug and abandon the CanKen 4 Federal #2 on 5/24/2007. Harvey E. Yates Company is still waiting for an available rig to perform the plugging operations. We requested and received an extension of time for operations until 8/14/2007. And, although this time has elapsed, we have not yet been able to secure a plugging unit to perform the work. We are still on the list for plugging services, yet no rigs have been available to commence the work as yet.

Since it is unlikely operations will be performed within the 90-day allotted period prescribed with the approval to p&a, we would like to request additional time to complete the plugging operations.
