**Disposal of Produced Water From Federal Wells
Conditions of Approval**

Approval of the produced water disposal methodology is subject to the following conditions of approval:

- 1 This agency shall be notified of any change in your method or location of disposal
2. Compliance with all provisions of Onshore Order No. 7
- 3 This agency shall be notified of any spill or discharge as required by NTL-3A
- 4 This agency reserves the right to modify or rescind approval whenever it determines continued use of the approved method may adversely affect the surface or subsurface environments.
- 5 Any on-lease open top storage tanks shall be covered with a wire screen to prevent entry by birds and other wildlife
- 6 This approval should not constitute the granting of any right-of-way or construction rights not granted by the lease instrument
- 7 If water is transported via a pipeline that extends beyond the lease boundary, then you need to submit within 30 days an application for right-of-way approval to the Realty Section to the BLM Carlsbad Field office at 620 East Greene Street, Carlsbad, New Mexico 88220-6292 for wells in Eddy or Lea County if you have not already done so
