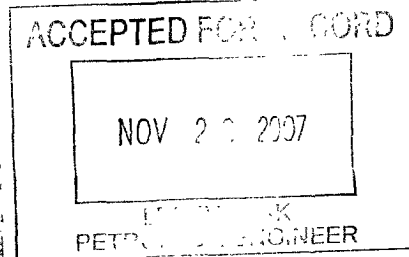

11/15/07 - POOH w/ work string & pkr. Hang well on pump.
