Cemented stage 2 with 450 sx 50/50 Poz "H" + 0.125#/sx Cellophane flakes + 0.7% FL-52 + 5#/sx LCM-1 + 1% Salt (yld 2.34, wt 11.8). Tailed in with 100 sx 50/50 Poz + 0.3% CD-32 + 0.5% FL25 + 0.5% FL52 + 2% salt (yld 1.28, wt 14.2). Cement circulated to surface. Tested casing to 1500 psi for 30 min. WOC 36 hrs 30 min. Reduced hole to 6-1/8" and resumed drilling.
