1. MIRU. POOH w/ rods and tbg.
2. Perf Yeso from 5670' - 5870' w 2 spf and 30 holes. Acidize perfs w/ 2500 gals of acid. Frac Yeso perfs with 89,200 # of 16/30 sand down tubing.
3. Set plug at 5620'. Perf Yeso from 5400' - 5600' w/2 spf and 30 holes. Acidize perfs w/ 2500 gals of acid. Frac Yeso perfs with 89,200 # of 16/30 sand down tubing.
4. POOH w/ frac string. Retrieve plug at 5620'. RIH w/ rods and tbg. EOT at 5900'. Restore production from 2615'-3392' and 5400'-5870'.

COG proposes to down hole commingle the Grayburg Jackson SR Queen Grayburg SA, (28509) with the Loco Hills; Glorieta-Yeso, (96718).

Commingling will not reduce the value of the total remaining production.

The proposed intervals are as follows:

Grayburg Jackson SR Queen Grayburg SA 2615' - 3392'
Loco Hills; Glorieta-Yeso 5400' - 5870'

Percentages to be determined after completion.

Ownership in all zones is the same.



