Moved in Teaco Rig #2. Spudded well at 22:00 hrs. on 12-12-07.

Drilled 17-1/2" hole to 756'. Ran 13-3/8", 48#, H-40 casing. Landed casing with shoe @ 756', float collar @ 715'. Cemented surface casing with 400 sx. 35/65 Poz/C and additives (1.95 yield and 12.7 ppg) followed by 200 sx. Class C and additives (1.34 yield and 14.8 ppg). Displaced cement with 113 bbl. fresh water. Circulated 84 sx. cement to surface. Bumped plug with 550 lbs. pumping pressure. Float held. Shut-in well and waited on cement.

Welded on 13-5/8" casing head. Pressure tested to 500 psi. Installed and tested 13-5/8" BOP. Pressure tested BOP to 1,000 psi. Picked up drilling assy. and prepared to drill out surface casing shoe.
