1/12/08 Set a CIBP at 9330' with cement. Tested casing to 500 psi, held good. Run CBL and check TOC at 8800'. Shoot 4 squeeze holes at 8600'.
1/14/08 Wireline set retainer at 8550'. Perforated 4 squeeze holes at 8300'. Circulated 5-1/2" and 8-5/8" annulus at 4 BPM at 800 psi, circulated 200 bbls, TIH with new retainer and set at 8250'. Tested retainer to 500 psi, held good.
1/15/08 Re-cement 5-1/2" casing from 8300' up to 5100' with 750 sx Class "H" cement with additives. WOC
1/17/08 Ran CBL from 8200' up to 4700', TOC at 4900'. Perforate Bone Spring 5922'-5966' (45)
1/20/08 Acidize Bone Spring with 5000g 20% IC acid and 60 balls
1/22/08 Set a CIBP at 5872' with cement. Perforate Bone Spring 5750'-5774' (145)
1/23/08 Acidize Bone Spring with 1000g 7-1/2% IC acid
