Tailed in with 200 sx Halliburton Light Premium Plus + 1.0% CaCl (yld 1.34, wt 14.8). Cement circulated to surface. Tested casing to 1000 psi for 30 min. WOC 58 hrs 30 min. Reduced hole to 8-3/4" and resumed drilling.
