This produced water is to be stored in a 500 bbl fiberglass tank until piped to the Bunnell Federal #3 SWD, operated by Apache Corporation, and located in the NW 1/4 of the SE 1/4 of Sec 18, T 21S, R 23E, Eddy County, NM.
