Displace w/ 69 bbls fresh water + 165 bbls mud. Differential pressure 1050 psi. Pumped 1/2 bbl over displacement. Did not bump plug. Floats held. Dropped stage collar bomb. Stage collar is at 7105'. Pressure up to open stage collar & inflate packer. 1800 psi. Circulated 114 sx of cement. TOC is at the stage collar.

1-24-2008 Circulate through stage collar. Cement 2nd stage: Lead- 1200 sx 50:50 Premium Plus cmt. + 10% Bentonite + 0.3% FL-52A + 0.125 lbm/sx Cello Flake + 5 lbm/sx LCM-1, Yield= 11.8, Wt.= 11.8. Tail- 650 sx 15/61/11 POZ Premium Plus: CSE-2 + 3% NaCl + 5lbm/sx LCM-1 + 6% FL-25 + 0.5% BA-10A + 6% FL-52A, Yield= 1.62, Wt.= 13.2. Displace w/ 165 bbls fresh water. Differential pressure 1800 psi. Bumped plug w/ 3000 psi. Floats held. TOC is at surface. ND. Set slips, install production wellhead & test to 3000 psi. Clean & jet pits. Release rig.
