3-25-08: Rigged up Halliburton, tubing @ 2566', circulated hole w/gel and spotted 25 sx plug. TOH to 2402', spot 30 sx cement plug. WOC 4 hrs. TIH tag plug @ 2244'. TOH to 2087', spotted 30 sx plug. WOC. Shut-in overnight.

3-26-08: TIH, tagged cement plug @ 1912'. TOH to 467' and pumped 125 sx CI C, 2% CaCl, 14.8# per/gal, 1.32 ft3 yield (used on all cement plugs). Cement circulated to surface.

Cutt off 7" casing and wellhead install marker.
