While in the process of converting this well to an injection, it was discovered that the casing was bad in the salt section. A decision was made to plug & abandon the well.

CIBP set @ 4110'. Squeezed perfs @ 2473' - 3322' through an SV EZ drill set @ 2420'. Made decision to plug & abandon the well. Called Jim Amos & got a verbal approval to set a 25 sack plug @ 2400' and a 50 sack plug @ 958'. WOC for 3 hrs. Tagged plug @ 530'. Set a CIBP @ 400'. Pumped 21 sacks to surface. Cut off well head & anchors. Install dry hole marker.
