

(This well was actually the BGSAU #6-5). On 4/3/08, Tandem Energy noticed the mistake in well #'s and notified Kendall Parker - Tandem Toolpusher. Mr. Parker immediately notified the on-call BLM Petroleum Engineer Technician. The true BGSAU #6-5 was spudded on 4/4/08.
