Additional cement required since cement on production casing to extend a minimum of 500' inside 9 5/8" casing.
The BEU #155 which is approximately 1/2 mile North encountered no porosity/permeability development in the Atoka and required a maximum mud weight of 10.5 ppg to drill the Atoka. The requested casing program is adequate to support mud weights in this range.
