**CHANGE IN BOP BECAUSE OF CHANGE IN RIG BEING USED THAN ORIGINALLY PLANNED**

After setting 13-3/8" surface casing, a 13-5/8" x 3M Diverter Stack will be installed to drill the 12-1/4" hole. This will consist of a 13-5/8" x 3M spool (mud cross) with a 13-5/8" x 3M annular preventer and rotating head on top. Upon setting 9-5/8" casing, an 11" x 5M BOP will be installed to finish the hole. This will consist of a 11" 5M spool (mud cross) and 11" 5M double stack with pipe rams and blind rams with rotating head on top.

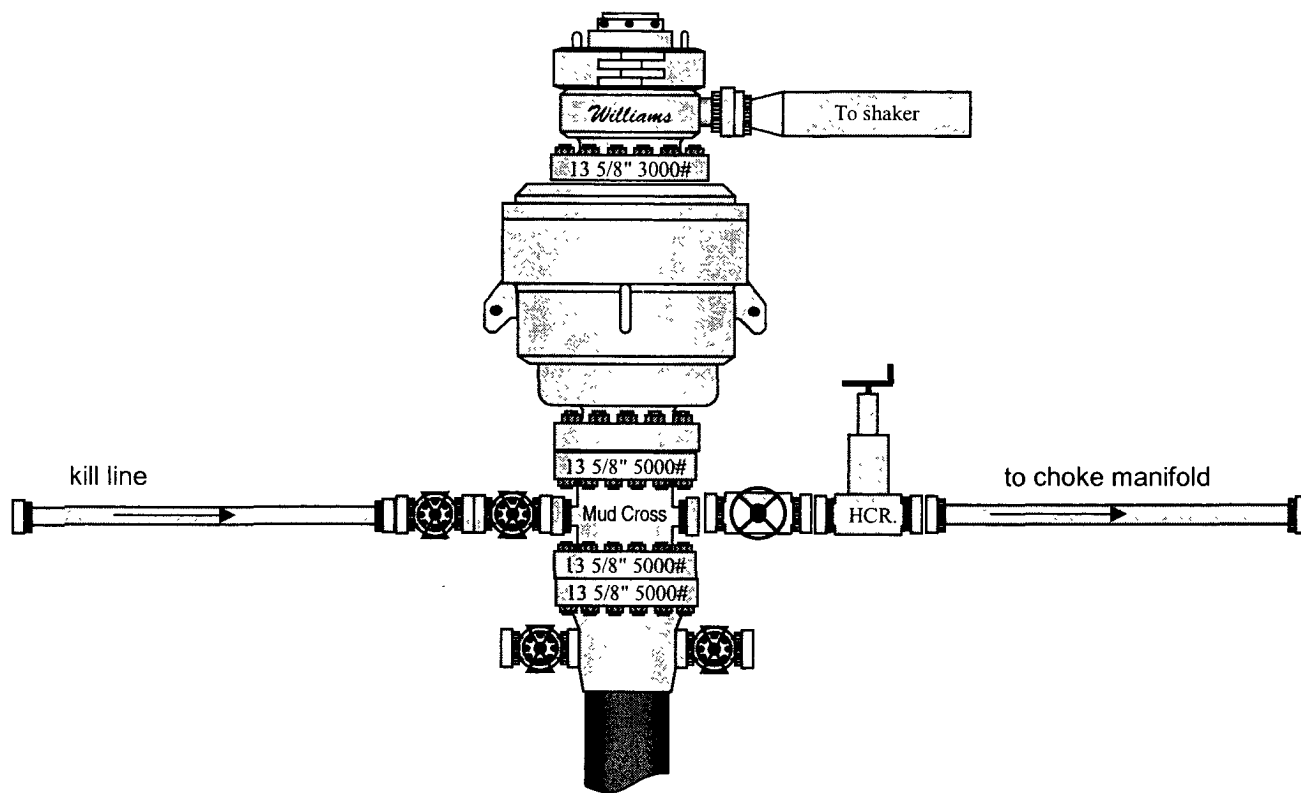
