Encore Operating respectfully request to conduct the following change in plans.

Due to lost circulation issues encountered in the Cisco Formations a second intermediate was required to be set before drilling the lower horizons (Strawn, Atoka, & Morrow).

7", 29#, L80 casing was set at 7630'. However, we did not circulate cement on this casing job.

Remedial cementing on the 7" casing would involve perforating and squeeze cementing. The following plan gives us the best option to have casing integrity, both for drilling ahead and completion operations.

At TD (+/-10000' MD) we will run a full string of 4-1/2", 11.6#, P110, LTC casing and circulate cement to surface.

Encore was given verbal approval from Mike Bratcher with the OCD on 5/15/2008.
