Moved in and rigged up. Spudded well @17:45 hrs. on 2-10-2008. Notified Mike Bradsher with NMOCD.

Drilled 12-1/4" hole to 454'. Ran 9-5/8", 36#, LT&C casing to 452' (float collar @ 410'). Cemented surface casing with 340 sx. Class C with 2% SI and 0.125 lb/sk. D-130 (yield = 1.34; weight = 14.8 ppg.). Waited on cement, nipped up BOP, and picked up bottom hole assembly. Drilled out shoe approx. 25 hrs. after cementing operations.
