- 4/29/08 Set 13-3/8" 48# H-40 ST&C casing at 720'. Cemented with 415 sx Class "C" + 0.25# Cellophane flakes + 2.0% CaCl<sub>2</sub> (yld 1.64, wt 14.8). Tailed in with 340 sx Class "C" + 2.0% CaCl<sub>2</sub> (yld 1.32, wt 14.8). Cement circulated to surface. Tested casing to 600 psi for 30 min. Reduced hole to 12-1/4" and resumed drilling.
- 5/6/08 Set 9-5/8" 36# J-55 ST&C casing at 3170'. Cemented with 900 sx 35:65:6 Poz "C" + 0.25#/sx Cellophane flakes + 5% salt (yld 2.04, wt 12.5). Tailed in with 400 sx Class "C" + 1% CaCl<sub>2</sub> (yld 1.33, wt 14.8). Reduced hole to 8-3/4" and resumed drilling. Tested casing to 1500 psi for 30 min.
