1. RU WL & RUN CBL.
2. SHOOT SQUEEZE HOLES IN 5-1/2" PRODUCTION CASING 10' ABOVE TOC BASED ON CBL. (TOC BEHIND 5-1/2" AT 4400' FROM TS). ESTABLISH CIRC ON 9-5/8" X 5-1/2" ANNULUS.
3. SET RBP AT ~ 4600". CAP W/SAND. TEST RBP TO 1500 PSI.
4. RIH W/CEMENT RETAINER & SET AT 30' ABOVE CIRC/SQUEEZE PERFS.
5. CIRC THRU RETAINER AND CEMENT W/ADEQUATE CMT TO BRING CMT TO 2340' (400' ABOVE 9-5/8" SHOE) PLUS 50 SXS. SQUEEZE TO 1500 PSI.
6. DRILL OUT RETAINER & CEMENT.
7. TEST SQUEEZE TO 1000 PSI. IF SQUEEZE HOLDS, CIRC CLEAN W/ KCL WATER. IF SQUEEZE DOES NOT HOLD, PREP TO RE-SQUEEZE AS DIRECTED.
8. RETRIEVE RBP. RETURN WELL TO PREVIOUS CONDITION.

BEP CO ALSO REQUESTS PERMISSION TO WAIT UNTIL THE MORROW AND ATOKA ZONES HAVE BEEN PERFORMED AND TESTED, AS REPRESENTED ON THE NOI APPROVED ON APRIL 23, 2008.
