Test additional Bone Spring Pay, perf the Upper 2nd Bone Spring Sand 7956'-64' (27) and acidize with 750 gals. NE Fe 7.5% HCL. If decision made to frac, will frac using low gel load crosslink fluid carrying 75,000 lbs sand.

Perf the "B" Carb 7820'-24' (10), (10) and acidize with 1000 gals. NE Fe 20% HCL.

Perf the lower 1st Bone Spring Sand 7512', 7513', 7514', 7515', 7516', 7517', 7518', 7519', 7520', 7521', 7609', 7611, 7613', 7615', 7617' (15) and acidize with 1350 gals NE Fe 7.5% HCL. If decision made to frac, will frac using low gel load crosslink fluid carrying 120,000 lbs sand.

Perf the Upper 1st Bone Spring Sand 7320'-30' (33) and acidize with 750 gals. NE Fe 7.5% HCL. If decision made to frac, will frac using low gel load crosslink fluid carrying 150,000 lbs sand.

Submit subsequent sundry - include new prod. test.
Work to be complete by 9/30/08
