6-11-08 Pumped 15 bbls 2% KCL down tbg. @ 2 pbm. Open bypass on pkr., release 5 1/2 HD pkr., POH w/ tbg & pkr., GIH w/ 5 1/2 Arrow Set & set @ 6580.25' top - 6588.85' btm. Pumped 10 bbls 2% KCL. ND BOP, install pack off rubber & set w/ 10 pts, install tree, test pkr. 5, 10, 15 min.- held 500# for 15 min.. Test pack off rubber to 3000# - held OK. Left well open on 24/64 choke. Turn well over to well testers.

6-12-08 RU swab. GIH w/ swab made 12 runs. Change choke to 18/64. SDFN turn well over to well testers.

6-13-08 Well testers on location.
