

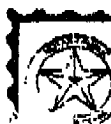

whose address is 1111 Bagby St., Ste. 4600 Houston, Tx 770022. That C. Tim Miller is the operator of a well drilled on land be-longing to Richard Nolte (Operator) Lime Rock Resources A, L.P.
(Landowner) (Richard Nolte) whose address is P.O. Box 362 Fort Sumner,NM. 88119, said well being drilled to test for hydrocarbons ~~XXXXXX~~
~~XXXXXX~~ gas and described as the Bell Estate No. 1, being located 1980
feet from the South line and 1980 feet from the East line of Section 17
Township 5 South, Range 24 East, NMPM, Chaves
County, New Mexico.3. That said well was drilled to a total depth of 4,300 feet, and that cas-ing has been set and cemented as follows:
13-3/8" set @ 875' and cemented to surface
8-5/8" set @ 1,704' and cemented to surface
4-1/2" set @ 4,300'4. That operator and landowner have made an agreement whereby operator
(1a) (to not) back fill pits, level location, and clear it of all junk. The agreement
further provides that operator is to plug said well back to a plugged-back total depth of
500 feet and transfer well to landowner for his use as a water-well. Operator will
leave casing in the well as follows:13-3/8" @ 875'
8-5/8" @ 1,704'
4-1/2" @ 550'5. That when operator has complied with the provisions of Paragraph 4 above
it will so notify the Oil Conservation Commission of the State of New Mexico on Com-
mission Form C-103, together with a signed statement from the landowner that the
provisions of Paragraph 4 above have been complied with to his satisfaction.
