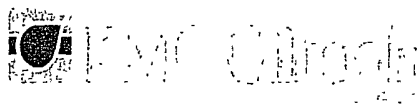
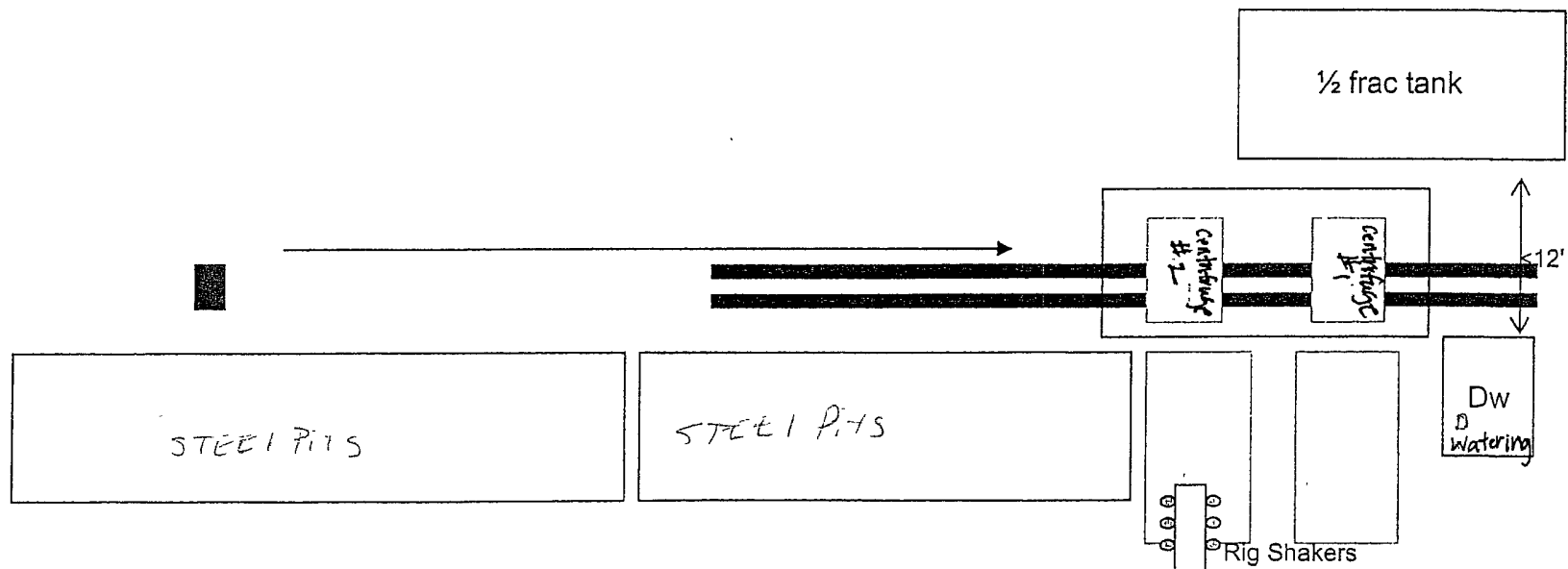

Minimum Space Requirement Layout



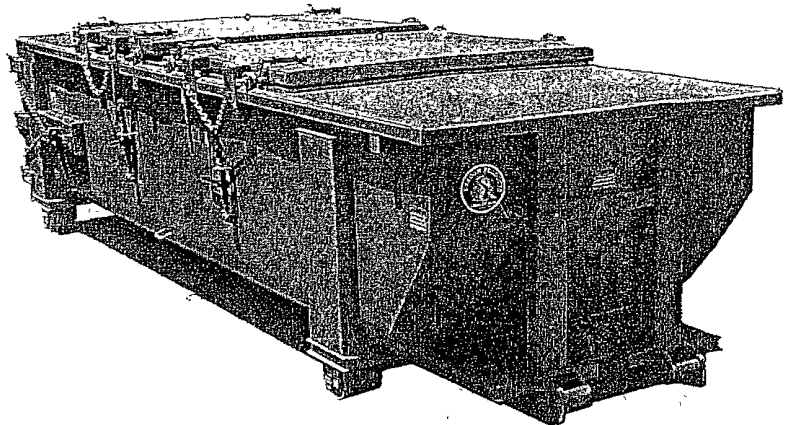
